Entries will be accepted only on the condition that all disputes, claims and objections arising out of the racing or with the respect to the interpretation of any rules or the conditions of races or otherwise shall be decided by the California Horse Racing Board, the stewards of the meeting, or the Los Alamitos Quarter Horse Racing Association, and such decisions upon all points shall be final.

Los Alamitos Quarter Horse Racing Association reserves the right to cancel or postpone any stake or handicap at any time prior to the actual running thereof, without liability except the return of nomination and entrance fees paid.

Los Alamitos Quarter Horse Racing Association reserves the right to divide the added money in any stake, which may be run in more than one division.

Los Alamitos Quarter Horse Racing Association reserves the right to draw all stakes and handicaps, with higher weighted horses preferred. Should a horse, which is entered, be excluded due to the above stipulations, all nomination and sustaining fees will be refunded.

Los Alamitos Quarter Horse Racing Association reserves the right to start all races with or without stall gate starting machine.

Acceptances in all stakes and handicaps must be made through the entry box by the usual time of closing.

The nomination or subscription to any stake to be raced at this meeting may be refused or canceled, without liability, at any time prior to the actual running thereof, except for the return of any nomination and entry fees paid.

Nominations in stakes are made with the understanding that said nomination does not assure stall space for horses nominated. In the event a horse is denied stable space all nominating fees that have been paid shall be refunded to the nominator.

Should any stake or feature race overfill it may be split and shall have preference over the other races scheduled for that day.

Important information for owners and trainers with horses nominated for futurities and derbies at Los Alamitos Race Course:

1. The trials for futurities, derbies, and other races with time trials will be conducted in the usual manner with post race testing by the California Horse Racing Board. All qualifiers (top ten) will also be blood and hair tested within 24 hours after the trials. At the discretion of LARC several other horses may be tested (i.e. qualifiers 11-15). Testing will be done by the UC Davis Equine Analytical Chemistry Laboratory. Horses with positive tests for “zero tolerance” drugs including but not limited to Clenbuterol, Albuterol, Zilpaterol, and Ractopamine, will receive a “non time” and will not participate in the final event.
2. For “Invitational” Stakes (i.e. Champion of Champions, Robert Boniface LARC Championship. etc.) pre race hair and blood testing will be done about 14 days prior to the race by LARC utilizing the UC Davis Equine Analytical Chemistry Laboratory.

We are confident that these measures will insure the integrity of the major stakes at Los Alamitos. We are doing our utmost to insure a level playing field for all of our good horsemen.

## CLENBUTEROL REGULATIONS AT ALL CALIFORNIA TRACKS

EFFECTIVE JANUARY 1, 2015, AUTHORIZATION OF A THRESHOLD LEVEL FOR CLENBUTEROL AS CURRENTLY ALLOWED UNDER CHRB RULE #1844(e)(6) WILL BE SUSPENDED FOR QUARTER HORSES AT LOS ALAMITOS. ACCORDINGLY, CLENBUTEROL WILL BE TREATED THE SAME AS ALL OTHER DRUGS THAT ARE NOT SPECIFICALLY AUTHORIZED BY THE BOARD. IF THE TESTING LABORATORY DETECTS CLENBUTEROL UNDER THE LABORATORY'S STANDARD OPERATING PROCEDURES, THE FINDING WILL BE REPORTED AS A VIOLATION. THE MADDY LABORATORY HAS EXTREMELY SENSITIVE TESTING FOR CLENBUTEROL. THE DRUG CAN BE READILY DETECTED AT LOW PICOGRAM LEVELS IN BOTH URINE AND BLOOD. A PICOGRAM IS 0.000000000001 GRAMS OR ONE-TRILLIONTH OF A GRAM.

HAIR TESTING WILL BE IMPLEMENTED IN ALL STAKES TRIALS AND IN SELECTED NON TRIAL STAKES RACES. OUT-OF-COMPETITION HAIR TESTING WILL CONTINUE ON A REGULAR BASIS.

ON FEBRUARY 28, 2014, THE CHRB ISSUED A SERIES OF INSTRUCTIONS CONCERNING THE USE OF CLENBUTEROL AT CHRB RACING ENCLOSURES. THOSE INSTRUCTIONS REMAIN IN EFFECT AND ALL HORSEMEN AND VETERINARIANS ARE EXPECTED TO COMPLY WITH THOSE INSTRUCTIONS ([http://www.chrb.ca.gov/veterinary\\_reports/medication\\_procedures.pdf](http://www.chrb.ca.gov/veterinary_reports/medication_procedures.pdf)). THE CHRB WILL CONTINUE TO USE OUT-OF-COMPETITION TESTING, INCLUDING HAIR TESTING, TO MONITOR COMPLIANCE WITHIN CONJUNCTION OF OUR EXISTING POST-RACE TESTING PROGRAM.

HORSEMEN AND VETERINARIANS SHOULD BE AWARE LOS ALAMITOS INTENDS TO ISSUE ITS OWN POLICY CONCERNING CLENBUTEROL USE THAT IS MORE RESTRICTIVE THAN CHRB REGULATIONS.

**HORSES PLANNING TO BE ENTERED IN GRADED STAKES OR TRIALS FOR ALL STAKES INCLUDING FUTURITIES AND DERBIES MUST BE ON THE GROUNDS AND REMAIN SO FIFTEEN (15) DAYS BEFORE THE RACE DATE. HORSES MUST BE REGISTERED WITH THE RACING DIRECTOR AND IDENTIFIED BY THE APPROPRIATE LARC STAFF. ALL HORSES MUST BE AVAILABLE FOR OUT OF PERFORMANCE TESTING AND INSPECTION AT ANYTIME, EXCEPT IN THE CASE WHERE THERE COULD BE AN EXEMPTION WITH A WRITTEN STATEMENT BY THE DIRECTOR OF RACING OR RACING SECRETARY.**

**\*\*\*\*\***

**ALL HORSEMEN ARE RESPONSIBLE FOR KNOWING THE RULES AND REGULATIONS OF THE CALIFORNIA HORSE RACING BOARD, HORSE RACING LAW AND THE RULES OF LOS ALAMITOS RACE COURSE.**

## STALLS

Trainers allocated stalls at Los Alamitos Race course are required to give immediate access to any horse under their supervision for purposes of inspection, examination, and/or drawing of blood, hair & urine for pre-performance or post performance testing by CHRB or Los Alamitos Race Course Veterinarians.

Horses which qualify in time trials for any race (futures, derby, stakes, etc) are **not** permitted to leave the grounds until 48 hours **after** the finals of the event in question. Violations will result in scratching of the horse from the finals and immediate and possibly permanent exclusion of the trainer.

Application for stalls should be submitted to: Jordan Castaneda, Director of Racing, Los Alamitos Quarter Horse Racing Association, 4961 Katella Ave., Los Alamitos, CA 90720.

Stall applications and Acknowledgement of Conditions for the Stabling of Horses agreement should be received by the Racing Office no later than January 1, 2023. It is requested that horsemen not apply for stalls for horses unless they will be ready to race at the opening of the meeting.

Stalls will be granted subject to 24-hour cancellation.

### **SHAVINGS WILL BE THE ONLY BEDDING MATERIAL PERMITTED.**

## LICENSES

The California Horse Racing Board maintains an office on the grounds of Los Alamitos. During the meeting licenses may be applied for or renewed at this office.

No horse will be permitted to start until both the owner and trainer are properly licensed. It is suggested that any owner who does not contemplate being on the grounds before the start of the meeting write directly to Los Alamitos for a license application blank.

## COMPENSATION INSURANCE

The laws of the State of California require every stable to be covered by compensation insurance. Such insurance may be obtained from Finish Line Self Insurance Group or an independent insurance group.

## TRAINING SCHEDULES

The track will be open for training between the hours of 5:30 am and 10:00 am, Tuesday thru Sunday. Reminder, the track is close on Mondays. Galloping or ponying of horses the wrong way on the track is not permitted.

## WORKOUTS

Two year olds and nonstarters and horses not having sufficient and satisfactory works or recent starts shall be required to work for the Starter and Clocker. Horses showing satisfactory workouts from the gate will be approved by the Starter. Horses must work using the same equipment with which it will be raced and the horse must be ridden out. All satisfactory workouts do appear on the official racing program. A list of all workouts is available at the racing office; please do not call the clocker immediately after works for times. For more information on current qualifying rules please contact the racing office.

**ALL 2 YEAR OLD PAPERS MUST SIGN IN AT THE RACING OFFICE FOR A RECORDED WORKOUT.**

### **BLINKER CHANGES**

Trainers requesting a blinker change must first secure a card from the Starter certifying that their horse has satisfactorily broken from the gate with or without blinkers, based on the requested change. The Paddock Judge with the consent of the Board of Stewards may or may not approve the change of blinkers. \*\*Please Note: This does not necessarily mean that the change of blinkers will be allowed.

**ALL BLINKER CHANGES MUST BE DECLARED AT TIME OF ENTRY.**

### **FLIPPING HALTERS**

Flipping Halters must be approved by the Starter and the Paddock Judge. Flipping Halters, whether it be continued, first time on or first time off must be declared at time of entry so that the change may be properly listed on the overnight and in the official race program.

### **CHANGE OF EQUIPMENT**

Permission to change equipment must be secured at the time of entry. The Paddock Judge will be on duty at the Racing Secretary's office for this purpose until the close of entries each day.

**ALL HORSES WILL CARRY THEIR EQUIPMENT TO THE POST.**

### **GELDINGS**

Geldings must be reported to the racing office when registration certificates are put on file. After a horse has started and is then gelded, it must be reported to the racing office and declared "first time gelding" the next time the horse is entered, as per CHRB rule #1865 (a).

**FIRST TIME GELDING MUST BE REPORTED AT THE TIME OF ENTRY.**

### **HEEL NERVED HORSES**

The Rules of the California Horse Racing Board require that a heel nerved horse must be reported to the Racing Secretary's office at the time it is registered for racing and the registration papers must indicate such nerving. If a heel nerving is to be performed after registration, the approval of the Board Veterinarian must first be obtained.

### **SPAYED MARES**

The Rules of the California Horse Racing Board require that a spayed mare must be reported to the Racing Secretary's office at the time it is registered for racing and the registration papers must indicate such change.

### **MARES IN FOAL**

**MARES IN FOAL MUST BE REPORTED TO THE RACING SECRETARY'S OFFICE.** The Rules of the California Horse Racing Board state that no person shall enter a mare in any claiming race when such mare is pregnant, unless prior to the time of entry the owner shall have deposited with the Racing Secretary a signed agreement whereby the owner at the time of entry shall provide to the successful claimant of such mare without cost, protest or fee of any kind a valid stallion service certificate covering the breeding of the mare.

### **AUTHORIZED BLEEDER MEDICATION (LASIX)**

First time bleeders and out of state bleeders must be registered on the California Bleeder List **prior to the time of entry** per CHRB Rule 1845(a)(2) to be eligible to receive Lasix on race day.

Horses coming off Lasix must register off prior to time of entry.

### **VETERINARIAN'S LIST**

Horses must be off the vet's list prior to the time of entry. Or have worked for the Official Veterinarian and must have a pass pending blood results prior to the time of entry.

Per CHRB Rule: 1866 (e) & (f) 4 year old Unstarted maidens and horses off for over a year are ineligible to start until they pass a satisfactory workout for the track vet.

### **REGISTRATION/FOAL PAPERS**

Horse Registration papers must be turned in to the Racing Office prior to working out or entering. Papers may be mailed to: Clerk of the Course Att: Isamar 4961 Katella Ave., Los Alamitos, CA 90720. For digital Thoroughbred papers please transfer certificate electronically to Los Alamitos.

Only registrations showing the true sire and dam will be accepted. All quarter horse registration papers must be issued by the American Quarter Horse Association and must have the "PARENT VERIFIED" stamp. Horses which have not "PARENT VERIFIED" will not be allowed to work or race.

Registration papers must reflect the true and current ownership and must be signed in under the current trainer.

No horse will be transferred without permission of the Stewards; transfers must be done using the appropriate forms\*\*\* Transfers and Bills of Sales must be signed by both the buyer and seller.

**Please Note: Per CHRB Rule 1662, No horse claimed shall be sold or transferred within 30 days of the claimed date**

**\*\*\* Bill of Sales must be signed in front of a Racing Official or they must be notarized no exceptions. Also, AQHA transfers do have a transfer fee which must be paid in order to be processed.**

### **OWNERSHIP**

Owners desiring to race under an assumed Stable name or LLC must have the assumed Stable name or LLC approved by and licensed by the California Horse Racing Board.

Your attention is also called to the following rule:

"Absolute and bona fide ownership of every horse, including each interest and ownership, shall be stated in writing under oath in affidavit form under penalty of disqualification, when required."

### **PAYMASTER OF PURSES**

The Paymaster of Purses office will be open 1 (one) hour prior to first post until the last race on each racing day.

All owners are required to have money on deposit to cover jockey fees prior to the starting of a horse. All purse moneys earned will be credited to the owner's account.

Prior to withdrawing any purse moneys from the owner's account, it will be necessary that the owner provide the Paymaster of Purses with his permanent address and either his Social Security or Tax I.D. number. Withdrawals may be made by the actual owners of the horses or their properly authorized agents. Only authorized agent licenses issued by the California Horse Racing Board will be recognized by the Paymaster of Purses.

### **ELIGIBILITY AND ALLOWANCES**

Starter Races, Plater Purses and Combination Races shall be considered races other than Claiming, except where the horse is entered in such a race for a claiming price or where the conditions state to the contrary.

Horses penalized in a race shall not be entitled to any of the allowances in such a race. Horses not entitled to the first allowance in a race are not entitled to the second and if not the second, then to no subsequent allowance unless specified in the conditions of the race.

Winners or non-winners of a stated sum means winner or non-winner of a single race of that gross value to the first horse.

The clause, "Races when entered for...not considered", applies to both eligibility and allowances unless otherwise qualified.

Owners and trainers, when entering horses, are cautioned to check carefully as to both eligibility and allowances claimed in races. The Racing Secretary will be glad to give horsemen any information in respect to their horse that is desired, but the final responsibility for eligibility and weight carried lies with the owners and trainers.

Your attention is called to the following California Horse Racing Board Rule: **NO PENALTY FOR WINNING CERTAIN RACES AT FAIRS.** A horse which wins a race at a fair meeting in this state shall not be penalized for such winning in races run thereafter at any race meeting other than a fair meeting if the net purse to such winning horse at such fair race is \$2,750 or less. This rule shall not apply to a maiden allowance which maiden allowance shall be lost by winning of any race.

### **CLAIMING**

Horses must be claimed in accordance with full registered ownership. If there are two or more owners of a horse through which a claim is made, all must be included in the claim and so recorded thereon.

A horse entered in a claiming race may be claimed for its entered price by **ANY** licensed horse owner who has a horse registered to race at the meeting where the claim is to be made, or by any licensed horse owner who has received a Claim Certificate from the Stewards, or by any person who has qualified for a license as a horse owner and who has received a Claim Certificate from the Stewards.

Any trainer claiming a horse and shipping out of California within 90 days may be subjected to losing or having stalls revoked.

**Please Note: Per CHRB Rule 1662, No horse claimed shall be sold or transferred within 30 days of the claimed date**

### **TRANSFER OF HORSES ON THE GROUNDS**

The purchase or transfer of any horse on the grounds of Los Alamitos whether by private sale, claiming or public auction does not guarantee the new owner or trainer a stall for such horse unless approved by the management.

### **AFTER-RACING EQUINE POLICY**

Any owner or trainer, who directly or indirectly participates in the transport of a horse from Los Alamitos Race Course to either a slaughter house or an auction house engaged in selling horses for slaughter, may have their stalls permanently revoked.

### **MOUTHING TO VERIFY AGE**

Any horse whose age is in question may be examined by one or more Veterinarians designated by the Los Alamitos Quarter Horse Racing Association.

The usual and natural development of the mouth and teeth shall, together with such other developments of the body which these Veterinarians deem relevant, be the standards on which findings may be based.

Should such examination, in the opinion of one or more Veterinarians designated by the track fail to confirm the age which the horse is represented to be or should any doubt exist on the part of one or more of the Veterinarians designated by the track to make this examination – entry on such horse may be refused.

### **SCHOOLING IN THE PADDOCK**

Permission to school in the paddock during the races may be obtained from the Paddock Judge.

### **PADDOCKING OF HORSES**

All grooms should be neatly dressed in appropriate attire when taking horses to the paddock. Also pony riders taking horses to the post in the public parade should keep themselves and their mounts well groomed and their tack clean.

### **JOCKEY ENGAGEMENTS**

Trainers must name a jockey at time of making entry.

A jockey may be named on two horses in a race provided one is on the also eligible list.

A jockey engaged to ride any horses is bound to fulfill his engagement unless excused by the Stewards. Should a rider become injured or ill on the way to the post or at the gate and the Stewards designate a substitute rider, such rider will fulfill the order of the Stewards and complete the engagement on the horse.

The attention of all jockeys and jockey agents is directed to the following California Horse Racing Board rule:

Failure to fulfill jockey agreement; "No jockey engaged for a certain race or for a specified time may fail or refuse to abide by his agreement, unless excused by the Stewards."

## IMPORTANT ADDED RACING OFFICE INFORMATION

No entry shall be received on any horse not stabled on the grounds of the association, unless its stabling elsewhere has been approved by the Racing Secretary.

The starters for a race shall be determined by lot in the presence of bona fide horsemen and the post positions shall be in the order in which they are drawn. The same method shall be employed in determining the starters and post positions in the races that are divided.

In any open race which is divided, a division of that race may be carded as a **CALIFORNIA BRED RACE**.

In races which are to be divided, horses trained by the same trainer will be separated if at all possible.

In races which have over-filled, an Also Eligible list of (4) four horses will be drawn. Should there be any declarations in the race itself, horses will be drawn into the race from the Also Eligible list.

In overnight races a maiden shall not exclude winners.

No entry shall be accepted from any stable not properly licensed.

All horses to be entered in a **CALIFORNIA BRED RACE** must be registered as such with the Pacific Coast Quarter Horse Racing Association prior to being entered. If California bred races are run as open races because of a lack of California bred entries, California bred horses will be given preference.

Overnight stakes races will be treated as overnight races for declaration purposes only.

No entry will be received except upon the condition that all disputes, claims and objections arising out of the racing or with respect to the interpretation of the conditions of any race shall be decided by the Stewards, and their decision upon all matters shall be final.

At the discretion of the Stewards, and without notice, the entries of any person, or acceptance of transfer of any entries, may be refused.

The Stewards reserve the right to withdraw or scratch any horse which, in their opinion, will not qualify for the race in which it has been entered.

Purses of all levels may be altered by less than optimal field size with concurrence from the Pacific Coast Quarter Horse Racing Association ("PCQHRA").

### **1000 Yard Point System**

1. Points are earned by running in 1000-yard races at Los Alamitos Race Course.
2. Every Dollar earned is 1 point, 1:1 Ratio.
3. Points for the 2024 Summer 1000-yard finals, Are earned between, Saturday, December 30, 2023-Sunday, June 16, 2024.(Finals to be ran June 23, 2024)
4. Points for the 2024 Winter 1000-yard finals, Are earned between, Saturday, June 22, 2024 - Sunday, December 1, 2024. (Finals to be ran December 8, 2024)
5. No points earned in the Finals, Stake/Handicap, or otherwise stated.
6. MUST have at least one point to enter into the finals.
7. Possible carry over of points -

\*50% of points earned towards the Summer Finals will be carried over to points earned for the Winter Finals IF your horse makes at least 2 start between (Saturday, June 22 2024 - Sunday, December 1 2024).

## PREFERENCE DATE SYSTEM RULES

All foal certificates registered with the Racing Secretary prior to 5:00 p.m. January 1, 2024 will receive a registration date which is the best possible date.

All horses registered after January 1, 2024 will receive a registration date corresponding with the day the foal certificate is checked into the Racing Office. The horse will retain this date until he actually draws into a race.

Once a horse draws into a race he will receive a running date corresponding to the date of the race. Each time a horse races, his date changes to correspond with his newest running date.

Preference dates are good for any distance or any type of race for which a horse is eligible with the exception of Stakes and Handicaps. However, Handicaps, Stakes, Nomination Races and their trials **WILL NOT** be considered in the preference date system.

Horses with dates established which re-enter but do not get in a race will keep the date previously established.

Horses which scratch or are scratched will keep their race date for the day they scratch. Any horse which scratches after scratch time will receive a scratch date for the day they scratch.

Preference dates are in order of oldest date having preference. In cases where a registration, running and scratch date are all the same, the registration date takes preference over a running date and a running date takes preference over a scratch date.

Preference dates will not supersede conditions of the race, (Cal-Bred, etc).

All non-maiden races are winners preferred unless otherwise stated in the conditions. All maidens will receive the least consideration.

Horses which are placed on the Stewards', Veterinarians', Starters', Identifiers' or Paddock list will be denied entry until approved to enter. Their preference date will not be affected.

Claims, transfers or sales have no effect on preference dates, (the horse keeps its existing date) as long as the foal certificate stays in the Racing Office.

**Horses will lose their dates when the foal certificate is checked out of the Racing Office.**

Trainers who enter two horses in the same race must prefer the horse with the oldest date.

The "INTODAY" rule will be in effect.

Exceptions may be made when in the opinion of the Stewards or Racing Secretary a horse would be unduly penalized. **IN ANY MATTER OF DISCRETION, THE STEWARDS' DECISION SHALL BE FINAL.**

## STABLE AREA REGULATIONS

Stable Area entry is restricted to owners, trainers and their employees, racing officials and the working press upon presentation of proper credentials. The employees of each stable and all persons having regular business in the Stable Area must register at the Racing Secretary's office, and be issued proper credentials. Persons wishing temporary entry into the Stable Area must state their business at the Stable Office and may be granted temporary passes. Wives of stable owners and trainers are admitted to the Stable Area upon presentation of proper credentials.

Parking is permitted only in the designated parking areas. All horse vans and trailers must be parked in the area designated for such parking. Dogs are not permitted in the stable area.

The use of electricity for heating, cooking and other unauthorized uses is not allowed.

The lighting and electrical arrangements as provided by the management are not to be altered in any manner.

The use of extension cords, lights, heaters or any electrical equipment not provided by Los Alamitos Race Course is prohibited.

Fire hose boxes and fire hydrants must remain in the clear and no type of obstruction is permitted. The hose is to be used for fire only.

Washing down the paved area between barns is prohibited.

No smoking is allowed in horse stalls, feed rooms and other hazardous areas.

Horsemen are financially accountable for repairs to race track property as a result of destruction by themselves, their employees and other personnel under their jurisdiction.

**NO OTHER TRASH, RUBBISH OR DEBRIS, SUCH AS CANS, BAILING WIRE, VET WRAPS, PAPER OR PLASTIC, SHOULD BE DEPOSITED IN MUCK PILES, THESE ITEMS SHOULD BE PUT IN THE TRASH CONTAINERS AT THE END OF THE BARN.**

**IF MUCK PILES ARE FOUND TO BE CONTAMINATED, FINES WILL BE LEVIED AGAINST THE TRAINERS WHO ARE RESPONSIBLE FOR THOSE MUCK PILES.**

**AT THE TIME OF VACATING STALLS, TRAINERS WILL BE RESPONSIBLE FOR THEIR ASSIGNED STALLS BEING CLEANED AND STRIPPED OF ALL BEDDING.**

**DIVISION OF PURSES OVERNIGHT RACES**

### **QUARTER HORSE, APPALOOSA & PAINT:**

#### FIRST TIME STARTERS

-Two year-olds; going 220yds need a minimum of one satisfactory gate work.  
-Two year-olds; going any other distance two works are required, one must be a gate work.

-Three year-olds and upward; need a minimum of two works, one must be a gate work and one work of which must be at 350 yards.  
Four year-olds and upward also need a work for the official veterinarian within 30 days of racing and pass a post-work blood test.

\*First work must be within seventy-five (75) days of starting, and the second work must be within sixty (60) days of starting.

\*Horses that don't have a qualifying works within ninety (90) days will need to re-establish eligibility.  
(See Above)

#### STARTERS

-Two year-olds and upward, which have been off for sixty (60) days or more, need a minimum of one work.

#### ALL HORSES

-Three year-olds and upward, which have been off one (1) year or more, need a minimum of two works within (60) days. One gate work and one work of which must be at 350 yards. And a work for the official veterinarian within 30 days of racing and pass a post-work blood test.

### **THOROUGHBRED:**

#### FIRST TIME STARTERS

Need a minimum of three works within (90) days, one of which must be a ½ mile work, as well as the approval from the Starter to be eligible to start.

Four year-olds and upward also need a work for the official veterinarian within 30 days of racing and pass a post-work blood test.

#### STARTERS

-Which have been off for sixty (60) days but less than (90) days, need a minimum of two works, of which one within (30) days and one must be a half (1/2) mile or more.

-Which have been off for (90) days or more, need a minimum of three works, of which one within (30) days, one within the last (60) days, and one must be a half (1/2) mile or more.

## MIXED BREED RACES:

**550 YARDS:** Quarter horses, a minimum of two works in the last sixty (60) days, one of which must be 350 yards or further. Thoroughbreds, a minimum of two works in the last sixty (60) days, one of which must be 3/8 mile or further. Listed below are the workout distance options:

- Quarter Horse: 220, 350, 660, or 870 yards
- Thoroughbred: 3/8, ½, or 5/8 mile

**870 YARDS:** A minimum of two works in the last sixty (60) days. One of which must be 660 yards or further for quarter horses, and one of which must be 3/8 mile or further for thoroughbreds. Listed below are the workout distance options:

- Quarter Horse: 350, 660, or 870 yards
- Thoroughbred: 3/8, ½ mile or 5/8 mile

**1000 YARDS:** A minimum of two works in the last sixty (60) days. One of which must be 870 yards or further for quarter horses, and one of which must be ½ mile or further for thoroughbreds. Listed below are the workout distance options:

- Quarter Horse: 350, 660, or 870 yards
- Thoroughbred: 3/8, ½, or 5/8 mile

### **TO ALL TRAINERS**

- All NAMED horses must have their papers in the racing office at the time of workout. If not, works may not be recorded. If they are not in the office at the time of the work, trainers must contact the Clocker.
- All UNNAMED horses must provide the Sire and Dam's name to the Starters and Clockers at the time of the workout.
- All works must be satisfactory to the Clocker, Starter, and the Board of Stewards. Please do not call the clocker immediately after works for the workout times. A list of all workouts will be available in the racing office.
- All horses that have been unraced for 120 days but less than 365 days will need an official shedrow examination **within 14 days of entry.**
- Four year-olds and upward non-started Maidens and horses that have been off for 365 days or more must work for the official veterinarian **within 30 days of racing** and pass a post-work blood test.
- Horses working off the veterinarian list; a 5/8-mile work at a minimum time of 1:03 and pass a post-work blood test.
- When working to get off the Steward's list; a 5/8-mile work at a minimum time of 1:05.4 is required.
- CHRB Claiming Rule 1663 simplified: Entered within 25 days: Winner– must start for at least 25% more than amount of which it was claimed for. Non-Winner must start for at least the same amount it was claimed. (This is added as an aid to help briefly explain CHRB rule:1663. All must abide by the Full CHRB Rule)
